**PHARMANIAGA CONTRIBUTES MORE THAN  
RM50K TO EARTHQUAKE VICTIMS**

**Kuala Lumpur:** Responding to MERCY Malaysia's request for medical aids, Pharmaniaga Berhad, a member of the UEM Group, today handed over RM42,000 worth of medical supplies and a cash contribution of RM10,000 to MERCY, in aid of the recent earthquake in Padang, Indonesia.

The supplies were mainly antibiotics, analgesics and pain killers, which were handed over to MERCY's Acting General Manager, Mohd Shaharuddin Asmani by Pharmaniaga Berhad's Corporate Communications General Manager, Akmal Baqi Mohamed Ariff.

Pharmaniaga has an Indonesian subsidiary company, PT Millennium Pharmacon International Tbk which has 29 branch offices all across the republic. The medical supply contributed is Pharmaniaga's gesture of giving back to the community of Indonesia.

According to Pharmaniaga Berhad Managing Director, Mohamad Abdullah, "Our presence in Indonesia makes us more poignant for us to heed the call of those who are in need of immediate healthcare attention"

In 2005, Pharmaniaga was the first local healthcare company to send humanitarian medical aid to the tsunami stricken Aceh through the Royal Malaysian Air Force. Pharmaniaga also sent 3 tonnes of medical supplies on board the Royal Malaysian Navy vessel KD Mahawangsa. Both donations were coordinated by the Ministry of Foreign Affairs Malaysia.

“This isn’t the first time we collaborate with MERCY. Our on-going projects like the health screening for AADK (Agensi Anti Dadah Kebangsaan) reflects Pharmaniaga’s responsibility as a caring corporate citizen,” Mohamad continued.
